# Amendments to Standing Rules

## Introduction

2. DASC is a private club. As an affiliated player, parent, guardian, or coach all are required to follow the rules and policies of the club. Failure to do so as a parent/guardian, player or coach may result in disciplinary action and/or suspension/expulsion from the club by a simple majority vote of a quorum of the Executive Board, as defined in Article V, Section 4(a) of the Constitution and Bylaws.

### **B.** Selection of Coaches and Coaching

5. Coaches are required to act responsibly in all circumstances

## **D. Selection of Teams and Skill Assessments**

10. The selection of players will be made in accordance with these rules, subject to Section 11 below.

## H. Refunds, Penalties and Copies of Bylaws and Rules

1. There will be a \$10.00 processing fee for all refund requests made in relation to the fall season following the last date of skill assessments and following February 15 for the spring season. Fall season registration fees will be refunded if the registrar or president is requested to do so in writing (by regular mail or e-mail) on or before June 15 of the year in which the registration fee is paid for U9 and above players and on or before August 1 for U6 and U8 players. Spring season registration fees will be refunded if the registrar or president is requested to do so in writing by March 15th of the year of the spring season for U9 and above players and on or before March 1 for U6 and U8 players.

4. There will be a \$25 late fee for returning U9 and above players registering after May 30 for the fall season and after February 15 for the spring season, and a \$20 late fee for returning U6 and U8 players registering after August 1 for the fall season and after March 1 for the spring season.

## Amendments to Constitution and Bylaws

# ARTICLE VI Section 4

Was voted to add the following language:

The vacancy will be advertised to find willing candidates for that position. There must be at least a 7 day waiting period before appointment and approval.

# ARTICLE X

NEW SUBSECTION B.

A board member may be removed from their position by a two-thirds vote of the Executive Board and Coaches' Council if he or she fails to attend, and give reason, for missing three or more board meetings within a 12 month period.
