Changes to Section X will read as:

X. Official Team Uniforms and Intellectual Property

1. The DASC uniforms, logos, names, and branding are all part of an essential platform to foster club unity and identify. It is essential that all players and representatives act in furtherance of these goals about team uniforms and intellectual property. To that end:

- a. The only uniform (s) that may be worn by any player when competing on behalf of DASC shall be the official team uniform (s), as approved by the Board. No player or coach may take the fields to compete in any uniform that has not been expressly approved by the Board in advance.
- b. The names "DASC, "D.A.S.C.," and "Dillsburg Area Soccer Club," as well as any club logos, and the club crest are the sole intellectual property of DASC. They may not be printed or reproduced on any goods or materials without advanced Board approval. This includes the printing of "unofficial" team apparel, regardless of whether it will be sold or distributed to others. DASC reserves the right to pursue any action, whether within these rules or pursuant to law, to protect its intellectual property.
